PURPOSE AND GOALS:

The focus of the Community Comprehensive Plan Advisory Group (CCPAG) Meeting #2 was to review priority drivers of change and identify high-level strategies that could best respond to them. In this meeting, CCPAG members reviewed findings from a public survey where community members had prioritized the drivers of change that they felt it was most important for the County to plan for. The CCPAG group then discussed how prepared they feel Benton County is able to handle each prioritized drivers of change. CCPAG members generated potential strategies and approaches the County can take to respond to the public-identified priorities. The goals of this meeting were:

- 1. CCPAG members will receive a high level overview of the BentonBelieves Community Comprehensive Plan Survey.
- 2. CCPAG members will hear the community's prioritized drivers of change and brainstorm potential strategies to best respond to them.

CCPAG MEETING #2 OUTCOMES:

CCPAG participants discussed robust strategies that would help the County prepare for the drivers of changes prioritized in the survey. Below are the prioritized drivers of change:

1. Natural Disasters & Climate Change - Top Priority

a. *Natural Resource Management*: Support wildfire prevention, watershed protection, and sustainable land use practices to reduce environmental risks.

2. Population & Changing Demographics

a. *Housing Availability & Affordability*: Population changes could affect housing demand and the need for new types of development.

3. Government & Funding Priorities

a. *Strengthening Public Engagement*: Foster trust and transparency in local government decision-making by improving community outreach and participation.

4. Economic Shifts

a. Land Use & Business Growth: New and existing industries may compete for space and resources, influencing how land is used and developed.

5. Technology & Remote Work

a. *Rural Housing & Economy*: Remote work could increase demand for rural housing while also supporting different local businesses and expanding job opportunities in new areas.

CCPAG members identified the following readiness (by voting with a red, yellow, or green slip; green being most and red being least ready) and strategies for each priority area:

Yellow/Red	 The current Comprehensive Plan strategy is aimed at resiliency and harm mitigation. In order to ensure the success of this strategy, Benton County needs to grow its tax base. The County currently has a disaster management plan that encompasses the entire county, even smaller jurisdictions. This plan is robust and has many strengths, however, it is not well known throughout the community. In order to ensure this plan's success, Benton County could prioritize educating the public on this plan and gathering feedback so that all residents feel represented. Immigrant populations aren't effectively connected with preparedness resources. Emergency response plans need to be accessible to multicultural and non english speaking individuals. Additionally, Benton County needs to ensure that these communities are included in and prepared for in emergency response plans. 	 Benton County's building stock isn't seismically prepared. Wildfires are becoming more common. The federal funding to handle disasters is not guaranteed and may not be a stable place to look for disaster relief.

Red	 There is a struggle between farmland and residential development, the agriculture and forestry land is well represented and can't be developed. To mitigate challenges presented by this, Benton County could maximize housing development in the urban fringe and infill areas. Zoning and land use restrictions present significant barriers to residential and commercial development. To ensure that Benton County is promoting housing growth, land use and zoning restrictions should be reviewed for barriers and adjusted as necessary. Housing is needed across types and pricepoints. To ensure Benton County is meeting the housing needs of its residents, the county needs to consider the need for workforce and affordable housing types. 	 There isn't sufficient land to build housing in Corvallis, rents are too high and it is too hard to build affordable housing. OSU brings a lot of knowledge and people to the county, but they aren't keeping up with housing production.

	• Housing development impacts infrastructure. To ensure that Benton County is prepared for housing growth, the County needs to plan for how the infrastructure can sustainably adapt to support that housing (such as not just building more big roads).

In addition, CCPAG members brought up the following thoughts and considerations:

- Additional approaches to engagement may need to be taken to connect deeper with youth and agriculture/forestry industry workers. However, Alsea has been engaging with high schoolers and OSU has additional avenues of engaging with ag and forestry, soil and water conservation.
- The parks dept undertook a review of the review and thought that it was passive and vague, however, where it was actionable it did well to accomplish its goals. They noted that the plan was particularly successful in the agricultural and forestry sections.

 CCPAG members reflected on the uncertainty of the times we are in regards to the economy, politics, and livability. One CCPAG member felt that the Comprehensive planning process should be delayed until there is more certainty on what the future will look like, but others felt that Comprehensive Plan could help address that uncertainty.
